# President's letter

We launch into a new APPA year with a fresh committee: same faces but with even more determination to protect and enhance our Parklands. Congratulations to Peter Austin who has been re-elected Deputy President, and has been a tower of strength over the past year.

I can give you a litany of issues and events which we have been concerned about over the past year, but for the sake of brevity I will indicate just a few: Adelaide Bowling Club activities, LeFevre Terrace playground, encroachment on Hindmarsh Square by RAA site redevelopment, designs for the Britannia intersection, Kent Town highrise development, and MacKinnon Parade flood lighting. And one of the more unusual: we were approached by the people of Port Lincoln to help save their public space Centenary Oval! We were successful.

The Adelaide City Council has finalised its biodiversity survey. Sadly, it falls short of the thorough inventory we had hoped for and expected.

One effect is that it leaves the delicate issue of the pine trees in Park 17 in no man's land. But, having heard a submission from Bushcare Australia about their native vegetation project at our first committee meeting, the new committee decided that in our opinion the pines should stay, and the Adelaide City Council should extend the area for the Bushcare project to the south where there is ample open space—surely a win-win situation.

The AGM in April was attended by 27 members. The Hon Iain Evans MP kindly agreed to be guest speaker. He talked about the concept of a Green Bank that could be used to finance conservation. His address provoked interesting questions and discussion.

Also at the AGM we enthusiastically supported a motion that Kyle Penick be awarded a Life Membership of APPA. Congratulations Kyle! He is currently in the US and missed the AGM. Sadly, his mother died recently and he remains there assisting his father. We send our sympathies to him.



The previous committee held a strategy meeting on 7 April to assess our progress and steer our efforts in the optimum direction. This is a 'work in progress' and we will consider strategy further at future meetings. We feel frustrated that we are constantly playing 'catch up' instead of being proactive and steering from the front.

Thank you for your support in the past year. The exciting challenges continue, so please, each of you, enrol at least one new member, for all our sakes.

Does anyone know how long mistletoe takes to establish itself?

Mistletoe (*Amyema sanguineum*) seems to grow only on mature trees. Does the germination take a long time? I have not seen mistletoe birds in the last ten years where I live just outside the East Parklands and near the river. We used to see two or three singing on the power lines in the street, where the trees had many bunches of mistletoe (lately tidied up).

However, on my 30-year-old Crepe Myrtle suddenly there is a mistletoe with half metre sprays. If it had been there last winter I would have seen it at leaf fall. Can I assume a mistletoe bird has visited us in the last year or so?

Here is a message: do not be keen to tidy up old trees too much.

# It was the saddest of times

The last couple of months have been the saddest that I have encountered regarding the Adelaide Parklands.

First, there was the final decision by the Adelaide City Council to go ahead with cutting down five significant trees in Hurtle Square despite there being no cogent reason for doing so except that the trees were in the way of a 'grand' design.

Then, I witnessed the final, intensive preparations for the car racing (sorry, 'entertainment' as it is now being described) in Victoria Park and the alienation of vast tracts of the Parklands for this event.

During the four-day event and even a few days before, the Parklands became a public toilet, a free-camping area, a gigantic car park and a garbage dump.

The already water-deprived areas turned to dust as thousands of cars were driven and parked in the centre of Victoria Park and along the Fullarton Road edge up to Greenhill Road. One afternoon, looking back along Gilles Street from Victoria Park, I couldn't see more than 50

metres because of the dense cloud of dust from cars driving across dry Parklands. Of course, the areas within the race circuit that were going to be featured in camera angles and were for the amenity of the participants were being watered conscientiously right up to the event.

The morning after, some of the discussion on 891 ABC Radio went along the following lines: there are so many people attending now that the promoters need more space and more permanent infrastructure; and the temporary grandstands sway when the people in them stand en masse and panic could result, therefore permanent grandstands are necessary. Oh, dear—here we go again.

As the constructions were dismantled, the true horror of dead grass, compacted soil, dust bowls and new 'roads' emerged. By the time everything has been removed there will be a bare seven months for remediation and recovery before it all starts again. This can't go on. It is unsustainable.

## BRITANNIA INTERSECTION THREATENS PARKLANDS

---

**The Britannia roundabout has long been a bone of contention for motorists and a potential issue of great concern for the Adelaide Parklands Preservation Association.**

Recently Transport SA produced a Concept Status Report which looked at a number of possible solutions to the problem of increasing traffic congestion and accidents at this major intersection.

The strategic decision to create an inner ring route around the city and to provide for substantial increases in commercial traffic, including B-Doubles, has put added pressure on the Britannia roundabout.

After a most informative briefing by Transport SA project officers, the APPA Committee is concerned that the traffic-light controlled multiple intersection proposal favoured by the experts would involve a substantial intrusion into the Parklands, mainly in areas currently leased to the South Australian Jockey Club (SAJC).

The resultant removal of many of the tawdry buildings erected over the

years by the SAJC, and presumably sanctioned by the Adelaide City Council, would be a positive outcome together with much-improved pedestrian crossings. But the cost is too high. The sad fact remains that, once again, appropriating dedicated Parklands is seen by the authorities to be an easy and acceptable way of solving a problem.

The continuing threat to Parklands preservation is incremental encroachment—the slow but relentless loss of the amenity which Light saw as the very essence of his visionary plan for Adelaide.

Whether it is motor sport, multi-function centres, commercial uses, carparking or the removal of trees, the impact on the Parklands is always the same: a loss of public access and enjoyment of our unique Parklands heritage.

Your committee will continue to closely monitor developments at the Britannia roundabout and work to ensure that there is no loss of Parklands to the ever-voracious demands of the motor vehicle.

## The final decision was made on 23 January to kill five significant trees in Hurtle Square.

Despite everyone's efforts, the Adelaide City Council (ACC) rejected all appeals to spare mature and significant trees in Hurtle Square. On the same day that Kelly Henderson was told that there would be a stay of execution to investigate legal implications of the decision, the 'Decision Notification Form' was being signed. It took five weeks, though, to convey this information—presumably the investigations were taking place.

What makes this process so difficult to understand and to fight, is that the developers making the application to remove the trees are the ACC, and the body giving approval is the ACC. See what I mean?

Apart from responding to the initial public consultation and subsequent notification, there are no other mechanisms that members of the community can employ against a Category 2 (which this one is) development.

One hopes that the public consultations about Parklands management will result in a better system. Please make sure that you participate in all opportunities to make your opinion known. The Parklands are being assaulted in small and large ways by people and organisations that see them as a tax-payer and rate-payer funded limitless resource for their own aggrandisement and/or for increasing their profits.

## ... but wait, there's more

### On 13 April 2004 the Adelaide City Council members met to decide the fate of pines in the Parklands immediately south of the main entrance to St Andrew's Hospital.

The removal of these two Canary Island pines and one Aleppo pine has been long campaigned for by the Trees for Life and Bush for Life groups. They believe the conservation of native grasses in that area would benefit from these three trees being removed.

Ignoring commonsense and viable other solutions to the perceived problem, and apparently limiting their insight to the report prepared by the Trees for Life group, the councillors voted overwhelmingly for the trees to be cut down.

The councillors' decision may now go to the Development Assessment Panel (DAP) according to some reports. The DAP may then set the final seal on the death of the pines.

The argument against cutting down the trees is based on the following:

- the pines are very old (more than 100 years)
- one of the pines is perhaps the tallest tree in the Parklands
- all the pines are important to Yellow-tailed Black Cockatoos as roosts and/or food sources
- the argument that nothing grows under the pines is also true of the large eucalypts in the same area and yet they have not been attacked by Trees for Life
- the area for further propagation of native grasses extends significantly from the original site and is not over-shadowed by any trees to the south
- grasses can be encouraged to spread and establish themselves in one or two years; the pines

have taken over 100 years to achieve their size

- the effort that volunteers have made to conserve native grasses, as laudable as it is, does not justify cutting down three significant trees.

The argument for cutting down the trees does not need elaboration here because it has been the most promulgated in all forums and supported by the extensive resources of Trees for Life and the ACC.

The outcome of this debate is still to be decided.

If you are a rate-payer in the city of Adelaide, remember to ask the councillors what they stand for and how they voted in this matter when you come to vote at the next council elections.
